ANY ACTIVITY ON THE BEACH AND SEA AREA IS UNDERTAKEN AT YOUR OWN RESPONCIBILITY.

- 1. Wind/Kite/Wing surfing is <u>not allowed</u> in less than a two hundred (200) meters distance from the usual point at which bathers reach by <u>swimming</u>.
- 2. The uplift of the kites must be done only when there are no people or animals or umbrellas, tents, sun beds or other physical obstacles within one hundred (100) meters around the user at the time of takeoff.
- 3. Everybody has to keep a distance of at least 50 m from other people in the water.
- 4. All water sports athletes have to stay at a minimum distance of 200m away from the coast and not further than 1 mile away from the shore.

Helmet, line cutter and impact jacket are obligatory for kite surfing Helmet, impact jacket and wetsuit are obligatory for Wind / Kite / Wing FOILING

- . Before starting ANY WATER SPORT, is the strict check of the perfect function of the equipment.
- Any water sports user starting from the beach to enter the water has priority and the water sports users coming out on the beach must
 give priority to the first ones.
- In a possible intersection of two kite boarders the left wind must give priority to the right wind and the windward (sofrano) must give priority to the leeward (stavento).
- In a possible intersection of a kite boarder with any other water sport athlete, except another kite boarder, the kite boarder is required to give priority and, at the worst case, hold the kite at the zenith.
- Jumps are not allowed on the beach. Before jump in the water look back.
- Jumps are not allowed generally without the rider firstly to look around and make sure that in a possible overthrew of himself or
 his equipment during his landing, in any way, he or his equipment will never be found closer than 50 meters from any person or
 other water sport athlete or from any other small or big boat.
- When a water sport user has no idea about the regulations and there is potential danger for impact of the equipment with third
 party the last minute handling should be clear, timely and stable as experience define, and not always in accordance with the
 regulations.
- Alcohol is forbidden during every water sport action.
- Our company does not accept any liability for lost or stolen equipment which was on the beach or in the sea. The same rules apply in
 case of fire, vandalism or other forces.
- Milos Beach & Partners Stuff reserves the right to remove the member Pass from any member who conducts water sports
 dangerously against other active members, or generally to other water sport users or bathers either in the sea or on the beach.
- Any Windsurf / Kitesurf / Wing Foil user who is not able to sail up wind & any kite surfer who/she is not able to lift up and land the kite without assistant must follow the appropriate MILOS BEACH WATER SPORT ACADEMY training programs, otherwise he/she is not possible to have the Pass active.
- WING FOILING & FLYBOARDING IS NOT ALLOWED FOR PERSONS UNDER THE AGE OF 18 YEARS OLD.
